Session Formats:

- Oral presentation: One presenter, with or without co-author; 10-minute presentation, 5 minutes questions
- Poster presentations: One presenter, with or without co-authors, dimensions: 1m x 1m (3.5 ft. x 3.5 ft.)
- Video documentaries: between 5 and 30 minutes, colour or black and white. Audio or not, permissions needed, as appropriate. Video documentaries are meant to provide an in-depth examination of a specific topic.

Abstract Submission Guidelines:

All abstracts must follow the guidelines outlined below:

1. Abstracts must be submitted by email to PIVPglobalconference2019@fspeel.org with the subject line "Abstract Submission".
2. Abstracts (from Rationale to Conclusion) should not exceed 400 words.
3. Abstract titles should not exceed 150 characters (including spaces) and should be lowercase.

- **Rationale**: What is the topic of your presentation? Why is this work important? What gap does it fill?
- **Objective**: What specific objectives did you have?
- **Methods**: What was done? How was it done?
- **Results**: What were your main conclusions?
- **Discussion**: What do your results mean? How do they advance current knowledge?
- **Conclusion**: What message do you want to leave with your audience?

Abstract for video should include:

- Rationale
- Objective
- Description/discussion points
- Key message(s)
- Conclusion

Please note:

1. Reviewers must provide sufficient data/information in the abstract to permit evaluation. Statements such as "additional information to be presented at the meeting" are not acceptable.
2. All speakers must be registered at the symposium. Please note that limited subsidies will be available to presenters who are students or survivors of violence. Successful abstracts may apply for subsidy at the time of acceptance.
